Chapter 1 - Rapid Change

Chapter 2 - Workplace Change

- 4) Technology accelerates productivity. How are you using technology? What new technology do you see in the future for your workplace?
- 5) "Man plans his way but God guides his steps." (The Bible) How might this idea help you to deal with today's rapid changes?
- 6) A businessman comments that "I get my current technical information off the blog web sites; by the time new information gets into print it's outdated." How do you feel about keeping up with the rapid growth, we see today, of new information via the internet?

Chapter 3 - Creativity

Chapter 4 - Rest

Rest: Ceasing from work...peace, ease or refreshment...relief or freedom from disturbance...mental or emotional serenity.

“Americans are richer than ever before, making money even faster than they can spend it, yet we are caught up in what I call the Wealth Paradox. This paradox is based on two faulty assumptions and two corresponding realities:

1. Assumption: When you accumulate money; you will enjoy greater rest, freedom and satisfaction.
Reality: Accumulation of wealth complicates life.
2. Assumption: When you accumulate money, you will have freedom from fear.
Reality: Accumulation of wealth brings a new fear: the fear of losing what you have. (Ron Blue, Generous Living)

- 2) Do you feel guilty when you relax? Explain your feelings.
- 3) What are the marks of a good leisure life?
- 4) Why do you think our culture is so fixated on work? And why do we reward the workaholic?
- 5) “Come to me, all you who are weary and burdened, and I will give you rest.” (The Bible) How might the concept bring rest in today’s culture?
- 6) How do you plan to use your vacations?

Chapter 5 - The Internet

We are living in exponential times; 2.7 billion searches are performed on google.com each month. 47 million laptops were shipped world wide in 2006. The number of text messages sent and received every day exceeds the population of the planet. The amount of new technical information today is doubling every 2 years. In 2006 over 106 million people were registered users of “my space”.

- 3) Is the internet simplifying or complicating your life and how do you feel about the changes?
- 4) Do you trust the information you are receiving on the internet? Why or why not.
- 5) The Biblical figure Paul observed, “They are always learning and never able to come to the knowledge of the truth”. How can we know what information is true and what is false?
- 6) What do you plan to do to leverage the internet for information and develop your relationships?

Chapter 6 - Ambiguity

“The information age is characterized by ambiguity. On the one hand globalization highlights the mega trends affecting our world through economic and religious power blocks, resulting in a clash of civilizations. Another factor is the emergence of communication networks, some of which are controlled by centralized media channels such as CNN or Al Jazeera, while others are decentralized and unregulated, such as the Internet. On the one hand large institutions, such as multinational companies and the militaries of Western nations, wield enormous power. On the other hand, networks of terrorist cells grab global attention and inflict significant damage, and small companies each with a handful of employees create 80 percent of the new jobs in North America and Europe.” (Leadership Next, Eddie Gibbs)

Discussion Questions:

- 1) Ambiguity – doubtfulness or uncertainty. Are you experiencing ambiguity? How so?
- 2) Do you keep up with current events via the media? How does the ambiguity of different source affect you?
- 3) It seems that each new day brings reports of terrorist activity. How are you feeling about your personal security? In your opinion is there a solution?
- 4) “Let no man deceive himself. If any man among you thinks that he is wise in this age, let him become foolish that he may become wise.” (The Bible) In light of today’s ambiguity does this statement make any sense to you? How so?
- 5) Today are you more or less secure, in what you need to be sure of, than you were 5 years ago? Why?
- 6) Are you doing business with large institutions or multinational companies or small businesses? How is this working for you?
